TELECOMMUNICATIONS ENGINEER CERTIFICATION CRITERIA AND INSTRUCTIONS

MASTER Engineer Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee. Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.
2. Hold current FCC General Radiotelephone Operator License (GROL).
3. Candidate must submit documentation outlining continued education and engagement within the telecommunications field.
4. Have a minimum of 8 years of experience as a telecommunications engineer. Provide current resume or complete the Detailed Work History section.
 - a. Candidates must hold an iNARTE Senior Engineer certification for a period of at least 1 year.
5. Using the iNARTE reference form, provide a minimum of 1 supervisory reference and 3 additional references. Each must be familiar with the candidate's experience and support the candidate's competence and character.

SENIOR Engineer Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee. Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.
2. Hold current FCC General Radiotelephone Operator License (GROL).
3. Candidate must submit documentation outlining continued education and engagement within the telecommunications field.
4. Have a minimum of 6 years of experience as a telecommunications engineer. Provide current resume or complete the Detailed Work History section.
 - a. Candidates must hold an iNARTE Junior Engineer certification for a period of at least 1 year.
5. Using the iNARTE reference form, provide a minimum of 1 supervisory reference and 2 additional references. Each must be familiar with the candidate's experience and support the candidate's competence and character.



JUNIOR Engineer Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee.
Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.
2. Pass the FCC General Radiotelephone Operator License (GROL) examination
3. Provide proof of education in the form of College/University transcripts or diploma.
4. Have a minimum of four (4) years of bona fide engineering experience in telecommunications. Provide current resume or complete the Detailed Work History section.
5. Using the iNARTE reference form, provide a minimum of 1 supervisory reference and 2 additional references. Each must be familiar with the candidate's experience and support the candidate's competence and character.

TELECOMMUNICATIONS TECHNICIAN CERTIFICATION CRITERIA

MASTER Technician Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee.
Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.
2. Hold current FCC General Radiotelephone Operator License (GROL).
3. Candidate must submit documentation outlining continued education and engagement within the telecommunications field.
4. Have a minimum of 8 years of experience as a telecommunications technician. Provide current resume or complete the Detailed Work History section.
 - a. Candidates must hold an iNARTE Senior Technician certification for a period of at least 1 year.
5. Using the iNARTE reference form, provide a minimum of 1 supervisory reference and 3 additional references. Each must be familiar with the candidate's experience and support the candidate's competence and character.

SENIOR Technician Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee.



Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.

2. Hold current FCC General Radiotelephone Operator License (GROL).
3. Candidate must submit documentation outlining continued education and engagement within the telecommunications field.
4. Have a minimum of 6 years of experience as a telecommunications technician. Provide current resume or complete the Detailed Work History section.
 - a. Candidates must hold an iNARTE Junior Technician certification for a period of at least 1 year.
5. Using the iNARTE reference form, provide a minimum of 1 supervisory reference and 2 additional references. Each must be familiar with the candidate's experience and support the candidate's competence and character.

JUNIOR Technician Certification Criteria

1. Complete the Telecommunications Application Form and submit application fee. Submission of the application form implies agreement to adhere to the iNARTE Code of Ethics.
2. Pass the FCC General Radiotelephone Operator License (GROL) examination
3. Have a minimum of 2 years of experience in telecommunications. Provide a current resume or submit the iNARTE Detailed Work History section.
4. Provide evidence of completed courses/training in radio and/or telecommunications. Photocopies of applicable training certificates or transcripts may be submitted.
5. Using the iNARTE reference section, submit a minimum of 1 supervisory reference and 2 additional reference. Each must be familiar with the candidate's experience and support the candidate's competence and character.
